Minutes of the fourth month were approved as presented.

Ann Bodynk presented the Treasurer's Report for April 2015. Year-to-date contributions are about 51% of budget.

For discussion or approval:

Outreach: Chris Field presented a proposal for having a Geocache site on the Meetinghouse grounds, perhaps under the handicap access ramp. Geocaching is an outdoor treasure hunting game using GPS-enabled devices. Participants navigate to a specific set of GPS coordinates and then attempt to find the geocache container hidden at that location. Players may take a trinket from the container and put in one of their own.

Having a geocache would be another way to make people aware that we are here. RE committee will also be involved in that the kids will help choose and create items to put in the container. This is approved.

June schedule: After some discussion, the schedule for June was determined. Closing exercises will be June 7. After Meeting for worship, the picnic in lieu of potlock will be at Maiden-

creek. Meeting for Business will be June 14. Maidencreek will open for the summer starting June 21. For the picnic, hospitality committee will coordinate foods and supplies, RE will have activities for kids, and Ann Bodnyk will arrange for a port-o-potty.

Shape-note singers. Peter Frank presented the annual request for the shape-note singers to use Maidencreek on September 5. This is approved.

Membership transfer: Lee read a letter from St Peter's UCC church, requesting that Brion Morrissey be released from Meeting membership as he joins the congregation there. This is approved. Lee will send a letter.

Report on Demonstrations at the Family Detention Center, Leesport PA

About 17 Families who are seeking asylum are being detained under lock and key near Berks Heim. Recently there were two demonstrations across the street from the center with the goal being that the families be released and the facility closed. On May 2nd about 150 people of all ages including children came and listened to many speakers (photo on page 1). There were several Quakers and several other Faith Community representatives from Berks County and Philadelphia.

From Judy Geiser: "At one point a woman and a young girl, probably her daughter, appeared on their side and sat at a picnic table. They waved and waved to us. The demonstrators waved back and chanted in Spanish "You are not alone." I was moved and also very sad that they were not at liberty to walk across the road and join us."

The second demonstration on May 8th was a last minute gathering of about 15 Berks Faith Community members when we heard that a reporter from NPR would be there. Some of us waited for more than two hours across the street from the facility. Between the reporter being late and our busy schedules we did not see the reporter.

However a couple of the lawyers and social service people did come to speak to us about the conditions inside and what a typical day is like. The families could use visitors from the outside world. We learned later that a "show" was put on for the reporter, organizing the women and children to participate in activities that they normally do not do.

From Jane Beck: "Protesting on both days were people of faith, acting on their Christian values, and passionate human rights activists. They believe there is a difference between refugees fleeing threats to their lives, and the term "Illegal immigrants" which is being applied to them. Legal technicalities shouldn't prevent Americans from acting on the fundamental values of human rights."

Please help support the families in their efforts to gain asylum by sending donations to Ann Bodnyk, RMM treasurer. Be sure to write on the memo line of your check or on a note with your check "Immigrant Detainees in Berks County". Make your check payable to RMM. These funds will be used to cover expenses such as fees for translators, travel costs or postage to obtain documents. Emotional support such as visits or yarn for craft projects would also be most helpful.

Taking part in the May 8th Vigil at the Family Detention Center were Peter Frank, Janet Lamborn, Jane Beck, Jim Russo and Lee Pickett. Efforts to meet with an NPR reporter were not successful.

Later, an attorney reported to Carol Anne Donohoe "These (folks) staged a crazy scene for that reporter. She walked through the facility with an entourage of happy ICE employees and they staged a huge scene outside (during lunch and a school day, residents commented how weird it was) full of bicycling, street hockey, water, soccer and more.

Because of the protesters they forced all the women in to play an unplanned game of bingo, mid day. while they set up the "cones" and placed ICE staff around the perimeter.

The women didn't like that they were being used. They didn't like that their children were being used. I told them a reporter was there as soon as I got there, the response "no wonder they forced us to play bingo and took our kids out during lunch!" **Thank you** The Berks Peace Community thanks Reading Monthly Meeting for allowing us to use your space for meeting for all these years and for your financial support.
